COVID-19: Scottish courts show willingness to progress asbestos disease cases

As the threat of COVID-19 continues to impact on us all, these are extraordinary and dangerous times, particularly for those affected by asbestos related conditions. The effects of Covid-19 could be more severe for those with a pre-existing asbestos related lung condition. This could have a bearing on any potential legal claim. If you, or anyone you know is affected, please contact us for legal advice.

At first the COVID-19 crisis brought personal injury cases in the Scotland's courts to a grinding halt. Hearings of evidence were cancelled and cases were put on hold. New court actions could not be commenced. This presented particular difficulty for many of our clients, classed as vulnerable individuals due to age or underlying respiratory conditions and who have been adhering strictly to the Government's shielding requirements. This was of great concern to the Industrial Disease Team at Digby Brown.. Having cases raised and resolved as quickly as possible is of critical importance, to reduce anxiety at this worrying time, avoid evidence being lost and to preserve entitlement to certain damages.

However, in recent weeks the courts have listened to our concerns. We are now able to commence new court actions on behalf of our asbestos disease clients. Hearings with Judges are taking place by telephone, video-link or other remote means. Despite opposition from some insurers' solicitors, we have persuaded the court to bring the dates of hearings in some serious cases forward by several months. We argued that not doing so would likely result in serious and permanent prejudice to these clients.

In one case for an Asbestos Action member diagnosed with mesothelioma, the insurer's solicitor expressed confidence that the court hearing scheduled for 12th May could not possibly take place and would require to be postponed, and showed no inclination to agree uncontroversial evidence or engage in constructive settlement discussions. Their position rapidly changed when it became apparent the court agreed with our concerns and was willing to make special arrangements to hear the case. This resulted in settlement of

the case for a sum in excess of **£300,000** a few days before the hearing was due to take place!

Resources permitting, the courts are starting to demonstrate a commendable willingness to embrace technology to ensure access to justice for those with asbestos related diseases is not affected by the pandemic. By taking a proactive approach, and working with the courts, we have been able to protect the interests of our clients during these very challenging times.

We know these are worrying times, and we know that many people will be feeling anxious about the future. Beware of scams

Unfortunately, some people are taking advantage of this unusual time to carry out scams.

Here are some of the scams we are aware of:

- People offering miracle cures or vaccines – there is no vaccine or cure currently available
- Home cleaning services
- People offering 'home-testing' kits for coronavirus – this is a scam as these are only offered by NHS
- Emails saying that you can get a refund on taxes, utilities or similar are usually bogus and are just after your personal and bank details
- Lots of fake products available to buy online that say they can protect you against coronavirus - these will not help
- Fake calls from people claiming to be from the police or your bank - please note your bank or the police will never ask for your bank details over the phone
- People offering to do your shopping or collect medication and asking for money upfront and then disappearing.

Be cautious and listen to your instincts, don't assume everyone is genuine. Don't be afraid to hang up, bin it, delete it or shut the door.

The UK asbestos forum



The UK Asbestos Forum of which the charity is a member has continued to campaign on behalf of asbestos victims over the coronavirus period.

Meetings have been held on Zoom and campaigning has been achieved through a variety of methods.

One of the main issues of concern was the possibility of a trade deal with the United States which would have meant a repeal of the asbestos ban. We have been told that this will not be the case, which is reassuring – at least for the moment.

If your condition changes

Please remember to contact us if your asbestos related condition changes. Once someone is diagnosed with pleural plaques, and contacts us, we turn to our legal colleagues as a civil remedy is the only option open for justice to be obtained.

However, if a few years later perhaps pleural thickening or asbestosis is confirmed then we can assist further through pursuing an Industrial Injury Claim with the DWP and our legal partners will be happy to advise on whether anything further can be done on the Civil Claim side.
